

## Angel City Vendor Agreement

Event: Angel City Rally April 14<sup>th</sup> – 18<sup>th</sup>, 2009  
Vendor Set-up is April 12<sup>th</sup> and 13<sup>th</sup> from 9am – 9pm

If you do not check in before 9pm you must wait until the next morning to do so.

A deposit of 50% of your vending space is due prior to event. The remainder of fees is due immediately upon check in. You must also present Angel City with a copy of your insurance with Angel City listed as additionally insured or your attendance will not be permitted.

There are no golf carts, ATV's, or glass bottles allowed. Please keep pets in your area and clean up after them.

**Fees: Inside Vending Booths/ Sizes are width x depth**

10' x 20' = \$400  
12' x 20' = \$440  
15' x 20' = \$600  
20' x 20' = \$800  
25' x 20' = \$1000

Larger booths are available first come first served. All spaces have three 20 amp receptacles and one 50 amp receptacle located at the back of each space. A \$10 per day fee is charged for electric on top of fees. The city also enforces a \$50 city license fee that they will collect during the event.

**Fees: Outside Vending Space**

10' x 10' = \$150  
10' x 20' = \$200  
20' x 20' = \$250  
20' x 30' = \$300  
20' x 40' = \$350

There is limited space for outside vending. Only those that require outside vending due to the size of products or type of product sold will be permitted.

Four passes will be included with each vendor location purchased. Additional passes will be regular gate admission whether it is for the day or all four days. Make sure to turn in list of names for people that will be using passes. If not on the list they will be asked to pay.

No part of your set-up may extend beyond purchased space. This includes tent tie downs, trailer hitches, campers, canopies, etc. Bring a minimum of 100' of all weather heavy duty extension cords. Angel City will not furnish extension cords.

**Rules:**

1. Accept assigned location. Locations will be assigned on a first paid first served basis.
2. You are responsible for Georgia sales tax and City of Unadilla permits.
3. All vendors are responsible for the clean up of their vending spaces.
4. Vendors may not sell any food or beverages unless they are an approved food vendor.
5. No Refunds will be made for any reason, any cancellation, any removal for cause, or act of God.

6. Failure to abide by these rules will result in removal from event and forfeiture of fees.
7. No exclusions will be granted. We will limit certain items so get your applications in early.
8. Four weekend passes per spot will be provided. Additional passes will be purchased for gate price.
9. You must bring a generator if you do not wish to pay the \$10 per day electric fee.
10. Running water is available on site. Please check with us rather than assume the set-up is what you'll need. You must bring suitable containers to handle your grey and black water and grease. A pump truck will be on premises.
11. One 20 amp outlet will be provided for outside vending where applicable.
12. All food and tattoo vendors must have general liability insurance with \$1,000,000 (one million dollar) coverage with Angel City listed as additionally insured.
13. All other vendors must have general liability policy with Angel City listed as additionally insured. No exceptions.
14. Absolutely no use of the name Angel City Rally on t-shirts, patches, jewelry, or any other merchandise to be sold at Angel City without prior written consent from an owner or manager.

Please list all items to be sold and be specific. Include pictures if you have them.
